## ODINECET Ocean Data and Information Network for European Countries in Economic Transition - Pilot Project web site



I have the pleasure to inform you that as a result of the kick-off meeting (held 25 March 2006 in the IODE Project Office, Oostende, Belgium) the project document for the establishment of the Ocean Data and Information Network for the European Countries in Economical Transition (ECET) was finalized and adopted.

In the first stages, the ODINECET network will focus on aquatic information mainly, building on the already existing preconditions and networks in the ECET-region, whom indicate a stronger support need for the information sector.

The project aims at constituting a capacity building strategy for Eastern and Central European participating member states linking training, equipment and operational support in a regional context, product- and service-oriented and using a multi-stakeholder approach.

Objectives of the project will include: (1) support the networking of aquatic libraries in ECET countries; (2) support the development of national aquatic information centres and national/regional projects; (3) providing training opportunities in marine information management, applying standard formats and methodologies as defined by IODE; (4) assistance with the development and dissemination of aquatic information, responding to the needs of the scientific community; (5) assistance to IODE in the recruitment of National Information Management Coordinators.

Aquatic libraries and information centres from European countries with economies in transition are eligible to participate in the project. Participants will be asked to contribute to the formulated and future ODINECET projects. Participants will also be asked to contribute to EURASLIC activities.

One of the first actions that took place in the work frames of the ODINECET project was the training session in basic marine information management (MIM) organized jointly by the IOC/IODE and EURASLIC at the IODE Project Office during 13-24 March, 2006. Among the 14 participants were aquatic librarians and information specialists from Bulgaria, Croatia, Estonia, Latvia, Poland, Russia and Ukraine. Course lectures and class assignments included such topics on marine information management as: strategic library planning, online access information sources and retrieval, collection development, on-line catalogues and their functions, e-repositories and

open access, benefits of international networking and others. Planning discussions for MIM Eastern Europe (ODINECET) as well as a presentation of results of the ECET Union Catalogue were also included.

Since 24 March 2006 Ludmila Kulagina from VNIRO (Russia) has become the coordinator of the ECET Union Catalogue Project instead of Maria Kalenchits, responsible now for the coordination of the ODINECET project. Further development of the ECET Union Catalogue will include linking with institutional repositories (full-text electronic format).

India has launched a new portal for journals with open access. Open J-Gate Portal is a product of Indian company *Informatics India Ltd* (<u>www.informindia.co.in/</u>) with aim to promote OAI.

This database includes more than 3000 open access journals, among which there surely is something of an interest for marine, freshwater and environmental libraries and their users. More than half of them are scholarly peerreviewed journals. There are direct links to more than

1,000,000 full-text articles on publishers' websites. The Open J-Gate site is updated every day. On the home page there are three searching options: *Quick Search, Advanced Search* and *Browse by Journal.* 

Browsing by journal gets you to the alphabetic journal list where it is also possible to search by words from the title. Advanced searching is possible by key word, title, abstract, author and institution. You can limit your search by Latest Update, Publication Year and Subject.

### EURASLIC XII Conference Ukraine - May 2007

Our next conference is to be held in Karadag, the eastern Crimea. In the Jurassic period, about 150 million years ago, Karadag had been an active volcano. Today this location is famous for the unforgettable landscape and unique biological diversity.

The Karadag Research Station was founded by T.I. Vyazemsky in 1914. More recently it was reorganized as Karadag nature reserve. Among the heritage left by T.I. Vyazemsky is the rich collection of rare and unique books and publications. At present, energetic efforts are made on creating electronic version of this collection, in particular, working out an electronic catalogue, scanning, creating .dejv files and offering an access through the Greenstone programme. Participants of the conference will see Karadag and the exotic vicinities as well as the rare book collection with their own eyes. We also hope that a survey of the work that has been done on

Vyazemsky's collection of books will be presented at the conference. The interest to old, rare and valuable publications feeds the never-ending spiritual and intellectual search of humanity. Many of the marine libraries have real treasures in their possession that deserve presentation and special discussion. The idea of creating an e-repository also implies preservation of modern specialized publications including grey literature. I would
